A Legacy of Love by Fran Newman, Ph.D.

As a very young girl growing up on a family farm in Iowa, Shila Wiebe always knew exactly what she wanted to do with her life. Her goal was to become a nurse and serve the Lord in some type of mission work. The dream of becoming a nurse was fulfilled at Hamline University in St. Paul, Minnesota.

Shila's mission journey took her to Taiwan for two years and to the Los Angeles County School of Nursing for 11 years, before she dedicated 26 years to teaching in the School of Nursing at Azusa Pacific University (APU). In each step of her career, Shila introduced Jesus as the model and lifestyle for caring for people, stressed excellence in all work, and encouraged students to minister in the community. She attributed so much to the strength of her parents, who instilled in her Christian values, a strong work ethic, and a desire to obtain a college education, which they did not have.

"The greatest strength of APU, in addition to the motto of 'God First,' is the priority of excellence across the campus in teaching, administration, and lifestyle," Shila said. "Going out into the community and providing care, opportunities, and evangelism are so important to the university today. Our diverse communities need us."

Shila's main focus for her investment in APU was scholarships for undergraduate nursing students. "Many students would not be at APU today if it weren't for scholarships," she said. "Another project I would like my investment to contribute to is a new state-ofthe-art nursing building. We need more space, even though the beautiful new science building is gracious in letting us share some of their space."

Throughout her life, Shila demonstrated a willingness to follow God wherever He led. She lived by the verse in Proverbs 3:5–7: "Trust in the Lord with all of your heart. Lean not to your own understanding. In all your ways acknowledge Him, and He will direct your paths. Do not be wise in your own eyes. Fear the Lord and shun evil."

At APU, Shila had the privilege of teaching her favorite subjects in medical surgical nursing, which included courses in oncology, gerontology, and pharmacology. She believed the courses she taught laid the foundation for the specialties in nursing.

"APU is included in my living trust because I agree with their philosophy of 'God First,' the priorities that are set by the leadership of the university, especially faith integration, and how faculty are encouraged to provide care for students," said Shila. "It's the whole Christian environment we experience at APU."

Although semi-retired from APU, Shila still stayed in touch with students, especially those in mission work and the military. They would share with her their joys, On October 23, 2009, when this story interview was conducted, Shila's face radiated with Christian joy as she shared her story. However, the APU family was shocked and stricken with grief when the news broke that she unexpectedly passed away on November 30.

Shila fulfilled her dream as a young girl of serving the Lord in many different types of mission work. We are so thankful that her mission journey brought her to APU for more than a quarter of a century as a faculty member, leader, and dear friend. She served with extreme Christian dedication to APU in and out of the classroom, and always exemplified Jesus as her model.

Although many didn't get to say goodbye, we know that Shila's legacy of love will live on through her gifts, her excellence in teaching, her compassion for students, and most of all, her love and commitment to her savior, Jesus Christ. actually live longer and have fewer medical problems.

Creating a Legacy of Love through a Bequest

Winston Churchill once said, "We make a living by what we get; we make a life by what we give." From our earliest days as a nation, Americans have demonstrated a remarkable spirit of generosity. Each year, Americans give more than any other country in the world.

Philanthropy has built remarkable educational institutions, cured deadly diseases, and continues to fund research and facilities dedicated to our health. Our generosity also funds religious, environmental, and social efforts from sea to shining sea. Yet, the vast majority of Americans are not able to give as much as they would like. The truth is that while many are limited by the realities of a day-to-day budget, a little careful planning today makes it possible for almost anyone to do more in the future to help those they love, including family, friends, and charity. The most frequent gifts made in a will or trust include:

A fixed bequest: This is the gift of a fixed dollar amount to a family member, friend, or charity.

A specified percentage: Many people divide their estate by percentages, leaving a specific percentage as to be divided among a named list.

A gift of a specific asset: On some occasions, gifts of a parcel of real estate or a block of stock help fulfill a desired objective to give to family, friends, or charity.

A residual gift: Specific bequests are often given to family members, and the remainder of the estate is divided equally among a variety of charitable causes.

Gift in trust: There are a number of appropriate ways to leave a gift in trust. For example, a trust can provide a surviving family with income for life, with the remainder going to charity after the death of the survivor. Alternatively, a trust may provide income to charity for a prescribed number of years, with the remainder ultimately going to a family member.

"Azusa Pacific University is rated very high on my list. I can't think of a better investment for God's money. It is a university with a commitment to the Lord." These are the first words you hear when Irene Hill begins talking about APU. "I've always loved God and remember at the age of 7 making a commitment to Christ at my church," she said. "I feel like I've been saved all of my life."

Irene knows the meaning of tragedy, as the lives of her husband, her only son, and daughter were cut short through accidents and illnesses. However, she finds a deep satisfaction in her Christian beliefs, her strong interest in biblical prophecy, and in the joy of sharing and giving. Several years ago, Irene established a life estate, which has given her significant tax savings, and also a gift annuity that provides income for life with more than half of that income tax free. "It's the best investment I have ever made, and I want my donations to be used where needed," she said. "I know it will always be used for a good cause."

Irene continues to attend the Free Methodist Church, where she grew up and met her husband-to-be, Paul, at age 12. They married when they were 20.

Irene and her husband were students at Los Angeles Pacific College in 1953, just a few years before the merger of Los Angeles Pacific College and Azusa Pacific College took place.
