"AMAZING" AZUSA PACIFIC UNIVERSITY

Gifford and Wini Claiborne have one descriptor for Azusa Pacific University (APU): "amazing." The university is amazing to them for a multitude of reasons. The tradition may have started with Gifford's father graduating from The Training School for Christian Workers—now known as APU—in Huntington Park more than 70 years ago. Wini's interest in APU began as a teenager when she heard the amazing choir in her hometown of Orangevale, California.

Both were raised in Christian homes, and accepted Christ as young children. They found their way to Azusa College—what APU was called at the time—where they met, married, and graduated in the early 1960s. Their three children attended the university (two graduated), and now their granddaughter, a recent graduate, represents

Everybody loves a bargain. There are some senior discounts available. But remember that it's important to always request the best rates available when traveling, since the senior discount may not always be the best deal.

Airlines: Southwest (www.southwest.com, (800) 435-9792) has the best senior fare program. American (www.aa.com, (800) 433-7300), Continental (www.continental.com, (800) 523-3273), and U.S. Airways (www.usairways.com, (800) 428-4322) also offer limited senior fares.

Car rentals: Most car rental companies offer 5–25 percent senior discounts. You can also find good deals through AAA (www.aaa.com) and travel aggregator sites like www.orbitz.com and www.kayak.com.

APU is "amazing" to the Claibornes, but the university could just as easily use the same descriptor for them. A milestone in the history of APU came in 1965 when Gifford was invited by Azusa College to come and recruit 30 students in a year. He recruited 300 in six months. Carefully consider a charitable remainder trust (CRT) with any stock or property you have that is worth more now than what you paid for it. A CRT is a favorite gift planning tool because it is flexible and versatile.

When you establish a CRT, you transfer your appreciated asset to the trust; the trust can sell the asset without paying capital gains tax. The CRT will
